AFTER FULFILLING ALL THE REQUIREMENTS OF THE ERF, ERAU-AI WAS AWARDED A FOUR-YEAR REGISTRATION IN FEBRUARY 2021. ITS INAUGURAL COHORT OF STUDENTS STARTED IN JANUARY 2022, PAVING THE WAY FOR THE NEXT LEVEL OF CERTIFICATION. AFTER THOROUGHLY REVIEWING ITS PROCESSES AND PROCEDURES AND CONDUCTING AN ON-SITE ASSESSMENT OF ITS OPERATIONS, THE CPE AWARDED ERAU-AI A FOUR-YEAR EDUTRUST CERTIFICATION IN FEBRUARY 2023.

FROM JULY 2023, ALL NEW ERAU STUDENTS IN SINGAPORE (EXCEPT THOSE JOINING GRADUATE DEGREE PROGRAMS OFFERED THROUGH A PARTNERSHIP WITH THE CIVIL AVIATION AUTHORITY OF SINGAPORE) WERE ENROLLED UNDER ERAU-AI. FROM JANUARY 2024, STUDENTS ENROLLED IN ERAU DEGREE PROGRAMS UNDER A SEPARATE PARTNERSHIP IN SINGAPORE WERE ALLOWED TO TRANSFER TO ERAU-AI. THESE MOVES WILL REPRESENT A SIGNIFICANT SHIFT IN OPERATIONS FROM ERAU ASIA TO ERAU-AI IN THE COMING YEARS.

THE CREATION OF ERAU-AI STRENGTHENS THE UNIVERSITY'S POSITION IN SINGAPORE AND THE SURROUNDING ASIA REGION, WHERE SEVERAL DECADES OF GROWTH IN THE AVIATION/AEROSPACE SECTOR ARE PROJECTED FOR THE FUTURE. THE PEI ENHANCES THE UNIVERSITY'S REPUTATION AND ITS ABILITY TO ATTRACT STUDENTS WHO VALUE ITS HIGH-QUALITY AVIATION/AEROSPACE DEGREE PROGRAMS.
